The convener apprised the members of the BOS regarding the following Agenda's:

- **Agenda 1: To Start M. Pharm. specialization in Pharmacognosy branch from academic session 2022-23,** because of increased demand and recognition of natural, herbal traditional drugs specially during pandemic.

The members agreed for the common syllabus in Pharmacognosy also for Modern Pharmaceutical Analytical techniques, MPH/MPC/MPL/MPG-101T, as approved in the last BOS held on 12<sup>th</sup> October 2019; along with other changes made in ordinance of M.Pharm. approved in academic council meetings held on 8.8.2018 and 7.2.2020 respectively. Rest of syllabus for Pharmacognosy branch is kept as per the M.Pharm course regulation 2014 of PCI.

- **Agenda 2: Regarding repetition of topics/content in M.Pharm. Pharmacology:** In MPL 102 T. Advanced Pharmacology I, unit III & MPL 201 T Advanced Pharmacology II. unit V, the topic Recent advances in Alzheimer and Parkinson diseases are repeated.

In MPL 104T Cellular Molecular Pharmacology, Unit II: Cell signaling: the topic Cyclic AMP is repeated in same unit. Therefore, the topic advances in Alzheimer disease, Parkinson disease in MPL 201 T & topic Cyclic AMP being repeated can be removed.

- **Agenda 3: Approval of Examiner Panel for B. Pharm, M.Pharm & D.Pharm.**

The panel was reviewed and approved by incorporating suggestions by external members of BOS.

- **Agenda 4: Regarding the increase in seats of B. Pharm. from 60 to 100 from academic session 2022-23**


The increase in B.Pharm. seats for better qualitative essential service provider to society, for the betterment of financial condition as well was discussed by BOS members for their suggestions. The external members suggested, first to have the minimum requirements of infrastructure. They suggested to have min. two classrooms of area at-least 1600 sq.ft. with audio visual facility.

Apart from this the members suggested to ensure the faculty requirement/cadre ratio applicable as per PCI/AICTE.

- **Agenda 5: Regarding D.Pharm. ER-Regulation-2020**

The discussion with all the BOS members concluded with the view to continue with ER-1991 till the enforcement of new ER-2020 along with syllabus by PCI.


