We are happy to inform that the service was launched by Shri Ramesh Pokhriyal 'Nishank', Hon'ble Minister for Human Resource Development, Govt of India, during the Special Session of Central Advisory Board of Education (CABE) on 21st Sep 2019 at Vigyan Bhawan, New Delhi in presence of 26 State Ministers, other MHRD and UGC officials. The Launching was also witnessed by Shri Prahlad Singh Patel, MoS (Independent Charge) for Ministry of Culture and Ministry of Tourism, Shri Kiren Rijju, MoS (Independent Charge) for Ministry of Youth Affairs and Sports and MoS, Ministry of Minority Affairs, and Shri Sanjay Dhotre, Minister of State for Human Resource Development

You must have received mail from contact@egalactic.in with your admin account details along with the admin guide. **You can now go ahead and create individual account for all the faculty members and research scholars.** There is no limit on the number of faculty members and research scholar that can be added. Please ensure the same is consistent with the details shared with PDS Inlibnet team (<http://pds.inflibnet.ac.in/Login>).

There is a soft cap on the total number of documents that can be submitted per University by INFLIBNET, this can be modified. This is based on the total number of users * four documents per user initially (for eg if there are 100 faculty and 150 research scholar the soft cap limit is $250 * 4 = 1000$ document per University). Once you reach 80% of the threshold documents, you will receive an alert mail from system. You need to request INFLIBNET centre to allocate you additional documents. Each document is defined upto 60,000 characters which is 20 pages of single line text approximately. Please ensure that the documents are judiciously used, and not submitted for trial purpose.
