## MEMORANDUM OF UNDERSTANDING

This Memorandum of Understanding (hereinafter called as the 'MOU') is entered into on this the 14<sup>th</sup> Day of February, Two Thousand Eighteen by and between CSJM University, Kanpur a college/institute recognized under Section 2f and 12 (b) of the UGC Act 1956 and having address at CSJM University, Kanpur, 208024, Uttar Pradesh, India THE FIRST PARTY represented herein by its Vice Chancellor / Representative (Director IQAC)

AND

HARE KRISHNA COLLEGE OF HUMANITIES, PASHU BAZAR LANE NEAR BHOLA BABA MANDIR SARSAUL, KANPUR THE SECOND PARTY represented herein by its Name of Competent Authority / Representative

### PURPOSE OF MOU

The Primary objective of this Memorandum of Understanding between CSJM University, Kanpur and HARE KRISHNA COLLEGE OF HUMANITIES, Pashu Bazar lane Near Bhola Baba Mandir Sarsaul, KANPUR is to create a means of cooperation between the two entities, subject to the terms of this MOU. It shall endeavour to strengthen, promote and develop practical knowledge, skill, training and development between the Parties on the basis of equality and mutual benefit.

### In particular, this MOU is intended to

1. To provide programme for comprehensive quality improvement in the teaching skill of the faculty of the college.
2. To focus on multiple training programmes based on the skill sets required as latest.
3. To Provide access to its resource materials in CSJMU.
4. To identify the area of research in computer application and provide support to promote research.
5. To generate strategic programming capabilities in students.



**NOW THEREFORE, IN CONSIDERATION OF THE MUTUAL PROMISES SETFORTH IN THIS MOU, THE PARTIES HERETO AGREE AS FOLLOWS:**

**Clause 1**

**CO-OPERATION**

- 1.1 Both parties are united by common interests and objectives, and they shall establish channels of communication and co-operation that will promote and advance their respective operations. The parties shall keep each other informed of potential opportunities and share all information that may be relevant to secure additional opportunities for one another.
- 1.2 The co-operation between First Party and Second Party will facilitate effective utilization of the intellectual capabilities of the Second Party providing significant inputs to them in developing suitable teaching/ training systems, keeping in mind the needs of the Second Party.

**Clause 2**

**SCOPE OF THE MOU**

- 2.1 Both parties believe that close co-operation between the two would be a major benefit to the student community to enhance their skills, knowledge and academic exposure.
- 2.2 The First Party will give valuable inputs to the Second Party in teaching/ training methodology so that the students fit into the educational scenario.
- 2.3 The interaction between HARE KRISHNA COLLEGE OF HUMANITIES, Pashu Bazar lane Near Bholu Baba Mandir Sarsaul, KANPUR and CSJM University will give an insight into the latest developments /requirements of the educational institution. The First Party to permit the Faculty and Students of the Second Party to visit CSJM University and also involve in Training Programs for the Second Party. The training and exposure provided to students through this association will build confidence and prepare the students to have a smooth transition from academic to working career.
- 2.4 The First Party will train the students of the Second Party on the latest trend in order to bridge the gap in skill and make them ready for society.
- 2.5 The First Party will extend the necessary support to deliver guest lecturers to the students of the Second Party on the technology trends and in house requirements.
- 2.6 The First Party will actively engage to help the delivery of the training and development of students of the Second Party.

### **Clause 3 VALIDITY**

- 3.1 The validity of the agreement is Three year from the date of agreement.
- 3.2 Both Parties may terminate this MOU upon 30 calendar days' notice in writing. In the event of Termination, both parties have to discharge their obligations. The parties may decide to further extend the term of this MOU by mutual consent on such term agreed between them.
- 3.3 Any dispute will be settled in the Kanpur Court only where the CSJM University, Kanpur is situated.

### **Clause 4: FINANCIAL ARRANGEMENTS**

- 4.1 This Memorandum of Understanding shall not give rise to any financial obligation by one Party to the other.
- 4.2 Each Party shall bear its own cost and expenses in the implementation of this Memorandum of Understanding.
- 4.3 If any of the activities mentioned above, wherever financial aspects are involved, a MOU unit, payment conditions, etc. would be spelt out clearly before starting the activity.

### **Clause 5: CONFIDENTIALITY**

During the tenure of the MOU and afterwards, unless both parties permit the disclosure, both Parties will maintain strict confidentiality and prevent disclosure of all the information and data exchanged under the scope of projects covered under this MOU.


### **Clause 6: AMENDMENTS**

No amendment or modification of this MOU shall be valid unless the same is made in writing by all the parties or their authorised representatives and specifically stating the same to be an amendment of this MOU. The modification shall be effective from the date on which they are made unless otherwise agreed to.
