



MEMORANDUM OF UNDERSTANDING



This MEMORANDUM OF UNDERSTANDING (MoU) made and entered into on this 10th day of July, 2021 by and between following parties:

- A. CHHATRAPATI SHAHU JI MAHARAJ UNIVERSITY, Kanpur which expression shall mean and include its successors in interest and assigns of the first part (hereinafter referred to as CSJMU), AND
- B. National Youth Foundation, Lucknow, which expression shall mean and include its successors in interest and assigns of the second part (hereinafter referred to as NYF)

WHEREAS CSJMU and NYF are interested in entering into MoU with a view of sharing a common desire to explore, extend and strengthen the functional relationship between the Academic Institution and Non-Governmental Organization, in order to share the common interest of serving the Society here with, sign this MoU on following broad understanding:

1. The NYF and CSJMU Kanpur, support each other in promoting various schemes related to public health, family planning, awareness generation activities, nutritional, maternal health etc, Research both long-term and short-term on various issues related with wellbeing of the society and commonly found in objectives of both the organizations, documentation of various programs and activities.
2. The faculty of Department of Social Work, CSJMU would assist in development of implementation plan related to various issues related with the organizations area of intervention, functional studies.
3. The CSJMU will provide technical expertise, specialized laboratory facilities and equipment support available at Department of Social Work, and/or any other division for which due expertise and facilities are available at CSJMU.
4. The CSJMU will assist NYF in imparting skills needed in professional social work to the workers of NYF in various sectors as and when needed or planned with the consent of both the organizations.
5. The NYF will support CSJMU in its extension activities and facilitate the practical exposure to the students from time to time.
6. The NYF would permit PG and/or Ph.D. students from the concerned departments of CSJMU such as Social Work or Adult Education etc for short- or long-term training in related areas.

7. The number and branch of students for such training/dissertation may vary from year to year and would mutually be worked out between the two organizations.
8. The students working at CSJMU, Kanpur will be allowed to avail the pilot scale facilities available at NYF and the Organization will extend all necessary support to the research students.
9. The CSJMU and NYF may apply for collaborative projects of mutual interest to external funding agencies.
10. Data generated through collaborative venture will be published/ patented by both the Organizations. The Intellectual Property Right shall be jointly shared by CSJM University, Kanpur and NYFH, Kanpur.
11. This MoU shall be valid for a period of 2 years from the date of signing. The duration may be extended with the consent of both the parties under mutually agreed term and conditions.
12. It is further agreed that the IQAC Director, CSJM University and Manager, Community Mobilization & Demand Generation of NYF, Kanpur; through periodic meetings will monitor the progress of this MoU. Any change/modification/termination as introduced/suggested will be in writing and will be binding on both the organizations.
