



**Memorandum of understanding  
between  
Unit of Science and Educational Development (UNISED)  
&  
Chhatrapati Shahu Ji Maharaj University, Kanpur**

This MEMORANDUM OF UNDERSTANDING (MoU) made and entered into on this 14<sup>th</sup> July, 2021 by and between following parties:

- A. Department of Social Work, Chhatrapati Shahu Ji Maharaj University, Kanpur, Uttar Pradesh** its registered office at Kalyanpur, Kanpur, Uttar Pradesh-208024, which expression shall mean and include its successors in interest and assigns of the FIRST PART (hereinafter referred to as DoSW, CSJMU), AND
- B. Unit of Science and Educational Development (UNISED)** established/incorporated under the Societies Registration Act 1860, having its office at UNISED -Rashtriya Avishkar Lab, BSA Office Campus Govind Nagar Kanpur, India (Government Department office of Kanpur Nagar) (hereinafter "Society" which expression shall unless it be repugnant to the context or meaning thereof be deemed to mean and include his heirs, executors, administrators and assigns) of the SECOND PART.  
(hereinafter referred to as UNISED)

WHEREAS DoSW, CSJMU and UNISED are interested in entering into MoU with a view of sharing a common desire to explore, extend and strengthen the functional relationship between the Academic Institution and Non-Governmental Organization, in order to share the common interest of serving the Society here with, sign this MoU on following broad understanding:


The UNISED and DoSW, CSJMU Kanpur, support each other in promoting various schemes related to public health, environmental issues, awareness generation activities, trainings, maternal health etc, Activities both long-term and short-term on various issues related with well-being of the society and commonly found in objectives of both the organizations, documentation of various programs and activities.

1. The faculty of Department of Social Work, CSJMU would assist in development of implementation plan related to various issues related with the organizations area of intervention, functional studies.



2. To utilize the research facilities of one institution by the research scholar, students, and faculty of other organization for innovative research work. By joint efforts of faculty, students, research scholar and members from both organizations may apply for collaborative projects jointly to national and international funding agencies.
3. The DoSW, CSJMU will provide technical expertise, specialized laboratory facilities and equipment support available at Department of Social Work, and/or any other division for which due expertise and facilities are available at DoSW, CSJMU.
4. The DoSW, CSJMU will assist UNISED in imparting skills/training/projects needed in professional way to the workers of UNISED in various sectors as and when needed or planned with the consent of both the organizations.
5. The UNISED will support DoSW, CSJMU in its extension activities and facilitate the practical exposure and training related to any exclusive activity to the students from time to time. And support the visits of students and faculty for purposes of academics, research, and field exposures.
6. The UNISED would permit PG and/or Ph.D. students from the concerned departments of DoSW, CSJMU such as Social Work or Lifelong Learning etc. for short or long term training in related areas.
7. The number and branch of students for such training/dissertation may vary from year to year and would mutually be worked out between the two organizations.
8. The students working at DoSW, CSJMU, Kanpur will be allowed to avail the pilot scale facilities available at UNISED and the Organization will extend all necessary support to the research students.
9. The DoSW, CSJMU and UNISED may apply for collaborative projects of mutual interest to external funding agencies.
10. Data generated through collaborative venture will be published/ patented by both the Organizations. The Intellectual Property Right shall be jointly shared by CSJM University, Kanpur and UNISED, Kanpur.
11. There will be no any financial liability on the Department of Social Work, CSJMU.
12. This MoU shall be valid for a period of 3 year from the date of signing. The duration may be extended with the consent of both the parties under mutually agreed term and conditions.




13. It is further agreed that the IQAC Director, CSJM University and Mr. R. C. Dwivedi, Head-Economics of UNISED, Kanpur; through periodic meetings will monitor the progress of this MoU. Any change/modification/termination as introduced/suggested will be in writing and will be binding on both the organizations.
