## BIBLIOTEX DIGITAL LIBRARY ONLINE PRODUCTS AGREEMENT (ACADEMIC)

The agreement is between Bibliotex, Address: Ground Floor, Green Park, New Delhi – 110016 E-Mail: bibliotex.com to Chhatrapati Shahu Ji Maharaj University, "Licensee", Address: Kanpur, Uttar Pradesh.

The Parties agree as follows:

**License Fee:** License agrees to pay Bibliotex the fees set forth in the invoice issued by Bibliotex or its authorized representative in accordance with the terms set forth therein.

#### License:

- O <u>License Grant:</u> Bibliotex grants license a non-exclusive, non-transferable, perpetual license to use the licensed products & to provide access to the licensed products electronically via the internet only to authorized users at authorized sites or via remote access in the accordance with the terms & conditions of this agreement. Bibliotex further agrees to provide license to support services set forth in schedule A.
- O Authorized Uses: License and its authorized users may:
  - Access, Search, Browse, and view the licensed products;
  - > Download and print documents for the scholarly or research use of authorized users and make a reasonable number of photocopies of a printed article for the scholarly or research use of Authorized users;
  - Print a reasonable number of pages from an eBook and make a reasonable number of photocopies of those printed pages for the scholarly or research use of authorized users.
- O Audit: License shall maintain accurate and complete records concerning its use of the licensed products "Records" for Perpetual. Bibliotex may, at its expense, inspect license records the equipment used by license this agreement "Inspection", provided that such inspection occurs not more frequently than once per twelvementh period and upon at least five (5) business days written notice.

otwithstanding the foregoing, if an inspection reveals that the license's use of the licensed products materially exceeds e scope of the rights guaranteed under this agreement, license shall be responsible for the reasonable costs of the spection and immediate payment to Bibliotex of an amount in addition to the license fee, based upon Bibliotex then irrent rate, for license's use of the licensed products beyond the scope of this agreement.

No adjustments shall be made for accumulating periods of non-continuous interruptions. No credit allowance will be issued for any interruption in license's access to the licensed products caused by any negligence or willful act of the license or failure of equipment, software or services not provided by Bibliotex.
