

AGREEMENT OF EBOOKS SERVICES BETWEEN

The Publishing Services Agreement (hereinafter "Agreement") is made and entered into by and between the Chhatrapati Shahu Ji Maharaj University, Kalyanpur, Kanpur- 208024 (Uttar Pradesh) (hereinafter "Client") and the InfoLibrary (hereinafter "Company"), whose address is 4/21B, First Floor, E-Block, Model Town-11, New Delhi-110009. This Agreement shall commence on date 08th January-2021.

THE COMPANY AND THE CLIENT WILL ACCEPT AND AGREE TO EACH TERM OF THIS AGREEMENT, WHICH INCORPORATES THE ATTACHED ANNEXES AND SCHEDULES.

COMMERCIAL TERMS

- "Article" means an individual document from the Licensed Products.
- "Authorized Sites" means the locations listed in Appendix B.
- "Authorized Users" means (a) persons affiliated with the Client as students, faculty, or employees; (b) authorized persons physically present in Client's library facilities; and (c) such other persons as Company may, at the request of the Client and in Company's sole discretion, authorize in writing to access the Licensed Products.
- "eBook" means an electronic book published by the Company in PDF format and made available through the Company's Portal.
- "Licensed Products" means the Company's online product(s) selected in Appendix A.
- "Remote Access" means access provided by The Company via secured authentication means only to students, faculty or employees of The Client who are not physically present at an Authorized Site.
- "Commencement Date" means the date the Company first provides The Client with access to the Licensed Products.
- License Fee. The Client agrees to pay the Company the fees set forth in the invoice issued by the Company or its authorized representative in accordance with the terms set forth therein.

COPYRIGHT AND PERMISSIONS

The Company holds the copyright on all eBook's materials in electronic form. All eBooks content is subject to "fair use" provisions of copyright laws.

RIGHTS AND RESPONSIBILITIES

A. Authorized Users

- A1. The purchase of the eBooks grants unlimited access to the full text of the eBook for educational, research and personal use by the faculty, staff, students, alumni, library patrons and other Authorized Users of the Client's campus/institutional network. Distance learners, alumni and other off-campus affiliates may access eBooks if their internet access is through the campus network or via a secure proxy server.
- **A2.** Client is expected to make their best feasible efforts to enable access to eBooks only to faculty, students, staff, alumni and walk-in library patrons using the campus' physical library facilities. There are no contractual limits on the number of Authorized Users from one campus at any given time.

B. Permitted

- B1. Provided that the copyright header attached to the eBook chapter is retained,
- **B1.1.** Download and print multiple copies of each eBooks for personal use and archive contents on their own personal computers.
- **B1.2.** Send multiple copies of eBooks by email, hard copy, or fax to one person in the Client's campus/institutional network at another location for that individual's personal use.
- **B1.3.** Distribute the copies of individual eBooks in print or electronic form to Authorized Users, including the distribution of a copy for noncommercial educational purposes, to each individual student (Authorized User) in a class at Client's institution.



ACCESS AND AUTHENTICATION

You acknowledge that all eBooks are protected by digital rights management technology, and that we may use this technology to enforce the terms of this disclaimer. The Company files server permits entry by recognizing authorized IP addresses. Distance learners and alumni who access the internet via campus IP accounts or a secure proxy server may use the Company, but direct access is not available through independent service providers. The Company will also provide login credentials as a method for remote access.

At the time an order is placed, the Client will provide IP addresses for all institutional networks and computers that require access to the Company eBooks.

The Client will make reasonable efforts to create and maintain appropriate security measures to ensure that only Authorized Users can access purchased content online. The Client also affirms that all IP addresses provided for use of eBooks are controlled by its institution exclusively for internet access by Authorized Users.

PERPETUAL ACCESS AND ARCHIVING

For access to be enabled, the Client must provide technical data about its campus or institution either via official email, or another mutually agreed upon method.

Provided that full payment of the total purchase price is made, the Client retains the right to perpetual access to the digital version of the purchased eBooks on the Company server.
